

CONTEST RULES AND REGULATIONS

Pro Organic

Article 1 : Organisation

The GHE company with capital of EUR 10,000, hereinafter referred to as "The Organiser", whose registered office is at, 4 boulevard du biopôle 32500 Fleurance, registered under number RCS Auch 402 002 307, is organising a Pro Organic® contest without the obligation to purchase from 15/12/2020 to 31/03/2021 at midnight (included).
